Floor length table covers are required, preferably in a neutral tone. Each vendor agrees to comply with set up times. Please be courteous of other vendors.

ENTRY FEE:

\$60.00 for booth space (approx. 10' x 7') plus 15% of sales.

TABLE RENTAL FEE:

\$10.00 per table. Please request and pay for at time of application.

VENDOR MEETING COMMITMENT:

Attendance at the Vendor meeting is <u>mandatory</u>, even for <u>previous participants</u>. At this meeting, we will discuss procedures, schedules, and all the details that help the show run smoothly.

If you would like to donate an item for our annual raffle, please bring your donation to the vendor meeting. More information will be provided in early September.

CORPUS CHRISTI FALL ARTS & CRAFT BOUTIQUE AGREEMENT FEES/CHARGES & GENERAL INFO

By participating in the Corpus Christi Fall Arts & Craft Boutique, you acknowledge the following:

Corpus Christi Roman Catholic Church - Tucson - is not responsible for any loss, damage, theft of your merchandise or personal belongings. Precautions will be taken; however, you assume the responsibility for your items.

Once approved, your entry fee is non refundable. If your application is not accepted, your entry fee will be refunded.

A commission of 15% of your gross sales will be deducted and the balance submitted to you, minus any additional fees. Checks will be mailed no later than 14 days after show.

If you are required to collect sales tax - PLEASE - build it into your price. If you do add tax to your price, please notify us at the vendor meeting by completing our tax form. We will make the proper adjustments so you do not pay the 15% fee on the portion of your sales which represent sales tax.

Offering the use of a credit card to customers increases sales.

The cost of offering credit is over 3% of each credit transaction. The credit card fee we collect does not cover the costs associated with our offering the use of credit cards. A nominal credit card use fee will be charged to all vendors, based on Gross sales, as follows:
